## INSTRUCTIONS



All assumed names governed under *Minnesota Statutes*, Chapter 333 are required to file an annual renewal once every calendar year after the time of expiration of their ten year term (effective in 2011). The annual renewal will be filed for the calendar year in which the current expiration date is listed. Filing this Annual Renewal does not satisfy any other legal requirement. If Minnesota statutes or rules require a filing with another office, you must submit that filing separately.

If changes to the assumed business name or principal place of business address are necessary, contact Paragon Document Research, Inc. (Paragon) for an amendment form. Amendment forms are \$60, which includes Secretary of State statutory and Paragon processing fees. Does not include county newspaper publication fees for New or Amended Certificates of Assumed Name.

**Note: You cannot use the annual renewal form to make Amendments to your Certificate of Assumed Name.**
